

PROPOSAL

Add after the existing paragraph: « The members of a Club may ALSO nominate and elect with the consent of the nominees TWO candidates as Presidents for the term of one year. Both shall share equally the duties and responsibilities of the Office

MOTIVATION

Internationally we experience an increasing number of Clubs disbanding, because nobody wants to take office as President out of professional, private and sometimes age-related circumstances. To help Clubs continuing their Membership we suggest a job-sharing model with two motivated and cooperative Club Presidents helping each other along the way. How this is organized is a Club matter and must be openly shared with all Club members on election day. Both names to be published in the official Inner Wheel Directories.

Add after National Representative "or each Deputy National Representative if replacing the National Representative":

To read: Each International Inner Wheel Officer, each Board Director, each National Representative, or each Deputy National Representative if replacing her National Representative and each Past President of International Inner Wheel is to be a Voting Delegate.

All of the above, if not represented, may designate as proxy provided they will be elected Voting Delegates at the Convention, a National Representative, or each Deputy National Representative if replacing the National Representative, a Past Board Member, a past Board Director, a District Committee Voting Delegate or the International Official Proxy Vote holder.

MOTIVATION

A Deputy National Representative is elected by all Clubs in the country to replace a National Representative who is unable to attend a Convention or any other event. If her presence is needed at a Convention, it is already in the law text which simplifies the whole process.

PROPOSAL

Add after The International Governing Body is to be elected as follows:

A maximum of **two** members from the same country can be represented in the International **Executive Committee**. Any voting paper declares a vote for more than two members of the same country, shall be invalid.

MOTIVATION

We are a global women's organisation with members spanning every continent. In keeping with the spirit of Inner Wheel, no more than two people from the same country should sit on an Executive Committee of five.

PROPOSAL

Add a new paragraph on page 10, between iv. "Voting and Tenure of office" of the CC and 2. Board Directors – a) Qualifications".

A country may nominate only one member to stand for Office on the IIW Executive Committee and International Governing Body. One member to be nominated for either President – Vice President – Treasurer – Constitution Chairman-Editor/MM. If a country receives nomination for more than one of the four Offices of the IIW Executive there must be an internal election to decide which Officer is elected.

MOTIVATION

As we are International inner wheel, to be International, all Officers of IIW governing body should be from different countries.

Following every vote for the election of the IIW Governing Body, a detailed report of the results shall be made public, including the total number of clubs voting and the number of votes cast for each candidate.

Empowering all members with access to comprehensive information regarding the election of the Governing Body isn't just a democratic principle; it actively strengthens the trust, engagement, and informed participation of every member.

PROPOSAL

After 2 add 3: "International Conventions will be organised in a hybrid form, allowing Inner Wheel members to participate either in person or virtually. If necessary, in virtual form only.

MOTIVATION

Thanks to the widespread use of digital technologies within Inner Wheel, it is now possible to organise the Convention in a hybrid format. This approach enables significantly greater participation by members in the most important event held by the International Inner Wheel. Moreover, smaller clubs or districts may not have sufficient financial resources to cover the travel expenses of Voting Delegates, but no member should be prevented from holding office due to financial constraints. If, for serious reasons, it becomes impossible to convene members in person, the Convention will be held virtually, as was the case with the 18th Convention—the first virtual Convention in Inner Wheel history.

Women who are already members of an Inner Wheel Club may become Dual Members of another Inner Wheel Club by paying the required Club subscription to their second Club.

An Inner Wheel DualMember May participate and vote at the meetings of both Clubs on matters relating to those Clubs, but she may only vote on Constitutional matters and resolutions on public affairs or stand for election as an Officer, Committee Member at her main Inner Wheel Club.

The Association may alter this provision by adopting bylaws to permit an Inner Wheel Dual Member to stand for election as an Officer or Committee Member in her second Club.

Each Dual Member must pay an additional subscription to her second Club as may be decided by Association, District and Club.

Termination of membership as stated in the bylaws.

MOTIVATION

Geographically some members find it impossible to travel to their main Club at times. To have another Club within the same District to belong to as a Dual Member would keep them in touch with Inner Wheel.

Clubs with low membership would benefit from additional ladies from another local Club supporting then in a range of ways. We hope that the host Club could then seek new members to boost their numbers.

We also have in place a five year strategy plan to take us forward into the next century. And the Association website includes a large amount of useful information for our members.

Inner Wheel must prioritise communication, mentorship, and inclusivity. Understanding members concerns and involving them in discussions will foster trust and collaboration. Recognising the past achievements and contributions of long-standing members will build a sense of value and respect. Mentorship and support will help ease fears and facilitate s smoother transition towards change. 
